ORDER:-

Whereas, as per letter received from Director General, Elementary Education Haryana, Panchkula vide Memo No. 1/5 2019 (ACD 12) dated 16.11.2024, concerned Deputy Commissioners have been authorized to take decision regarding discontinuing of physical classes upto 5th Class in Schools after assessing the prevailing situation of Air Quality Index (AQI) in the district.

In the wake of above letter, Air Quality Index (AQI) situation in District Gurugram was analysed on 17.11.2024 and 18.11.2024 and discussion was held with concerned officials and it came to fore that Air Quality Index (AQI) has been in "Very Poor" category & deteriorated to "Severe" category in some areas of the district in last 24 hours.

Therefore, in the interest of the health and safety of the children, it has been decided that all classes upto 5th standard will remain discontinued from 19.11.2024 to till further order in all areas (urban as well as rural) of District Gurugram. Online classes will be conducted in lieu of physical classes, in all Government & Private Schools in the district for above mentioned classes. Strict compliance of the above orders is be ensured positively.
